Know what it means!

- ▶ Intention:
- ▶ Target students that are moving toward the TASC test to achieve their HSE diploma
- ▶ It is meant to expedite their learning opportunities and concentrate their efforts on only those areas where they need improvement

Fast Track

Know what it means!

GRASP (math specific) distance learning packets (paper or electronic) utilizing NYSED/CUNY eight (8) HSE math modules for students choosing to learn from a distance learning model

Six (6) hour intense math instruction sessions made available evenings and Saturdays

Two x Two sessions where two sub test (one math and one other sub area) areas of instruction will be offered

Test taking skills and strategies, including reduction of test anxiety

Computer based testing skills and strategies as an option

Community outreach campaigns

Other customized Fast Track strategies designed by program staff (with NYSED approval)

Fast Track

Know what it means!

1. No NRS requirement that students must attend 12 hours before they count;
2. No valid pre or post-test requirement;
3. No Educational Gain calculated;
4. No TABE testing requirement. All participants must be tested with the TASC readiness assessment forms 6 and 7. Students who score between 400 and 500 should be recorded in ASISTS as FAST Track students with subtest scores entered;
5. No requirement for diploma recipients to be from NRS Levels 5 or 6. Students may be served at lower levels than required by NRS;
6. No employment follow-up for students/test takers; and
7. No requirement for HSE diploma recipients to have employment or postsecondary training

Fast Track Know what it means!

Students can be enrolled in Traditional Programming
AND still receive FAST Track advantages

The balance happens when a student is enrolled in any class that
is also coded with EPE or WIOA (Area 1, 2, 3, or 4)

The student is then included on the NRS performance report

Fast Track EPE ONLY = no NRS criteria

EPE or WIOA (Area 1, 2, 3, or 4) = Total NRS compliance

EPE or WIOA PLUS Fast Track = Total NRS Compliance

Regardless EPE contact hours are all reimbursed!

Fast Track GRASP Math Packets

Each packet contains a section on language skills

- Specific language associated with the types of questions related to that math skill packet
- Emphasizes the need for students to understand the TASC questions well before they attempt to solve each one

Fast Track GRASP Math Packets

Each packet = 24 contact hours = 2 week period

Part 1 = 24 contact hours = 2 weeks

Part 2 = 24 contact hours = 2 weeks

- Student may come in for face to face tutoring time
- Up to 6 hours per week for a total of 12 contact hours in a 2 week period
- These must be set up as traditional classes with EPE Fast Track funding code attached to the class

Follow Up Outcomes

- ▶ Employment

- ▶ 2nd Quarter after exit
- ▶ Includes wage information (wage in 1 quarter)

- ▶ Employment

- ▶ 4th Quarter after exit

- ▶ For students with SSN# recorded in ASISTS
- ▶ Data match is done electronically, program does not enter any information
- ▶ Manual Survey, data must be entered in ASISTS

Measurable Skill Gain

▶ HSE Diploma

- ▶ Must submit a T-TAF
- ▶ Only way to receive credit for the diploma
- ▶ No manual entry
- ▶ Regardless of student's Educational Functioning Level, the diploma is counted for MSG

Follow Up Outcomes

▶ HSE Diploma

- ▶ One year AFTER exit
 - ▶ Within that first year after exit,
 - ▶ Student must be employed OR enter training
-
- ▶ **Manual Survey, data must be entered in ASISTS**
 - ▶ **ONLY for students in NRS Levels 5 or 6**

Follow Up Outcomes

Credential Attainment

- ▶ Option will be available in ASISTS after February deadline
- ▶ **Manual Survey, data must be entered in ASISTS**

- ▶ Funded under EPE Fast Track
- ▶ No expectations for NRS criteria

- The CURRENT six month total is 1,382 plus the previous six month total of 1,781 = 3,163
