If approved, and in accordance with the program’s Hybrid & Remote Instruction approval letter, all policy updates issued by AEPP must be administered as directed. These updates have been made to enhance student support. Adult education programs must carefully review guidelines. All program managers must annually complete the Hybrid/Remote training offered by the RAENs, Accountability and Regional. If a program is deemed to lack sufficient experience with remote instruction, it will be required to attend digital literacy training provided through the RAENs.

EPE Distance Education Tutoring is not intended to function as synchronous, classroom-style instruction, rather, distance education packets are designed to address the individualized needs, goals, and pacing of each student. Accordingly, tutoring should align with this model by providing flexible, student-centered support that reinforces packet content, addresses specific learning gaps, and promotes independent skill development rather than replicating real-time group instruction. Programs intending to provide remote tutoring must have students complete both the Distance Education and Hybrid/Remote Screening Tool.
